19 The District Attorney of the San Luis Obispo County, California, hereby accuses the  
20 above named defendant of the following criminal offenses:

21 Count 1

22 On or between April 1, 2016 and August 23, 2016, in the County of San Luis Obispo, State  
23 of California, the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony, was  
24 committed in that CODY ADAM JULIAN did willfully, unlawfully, and lewdly commit a lewd  
25 and lascivious act upon and with the body and certain parts and members thereof of B.N.,  
26 a child under the age of fourteen years, with the intent of arousing, appealing to, and  
27 gratifying the lust, passions, and sexual desires of the said defendant and the said child, to  
28 wit first incident by the truck.

1 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code  
2 section 290. Willful failure to register is a crime.

3 NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse  
4 Report (SCAR) may have been generated in this case. Penal Code Section 11167 and  
5 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to  
6 obtain a copy of the report.

16 The defendant kidnapped B.N. in violation of P.C. 207.

17 Count 2

18 On or between April 1, 2016 and August 23, 2016, in the County of San Luis Obispo, State  
19 of California, the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony, was  
20 committed in that CODY ADAM JULIAN did willfully, unlawfully, and lewdly commit a lewd  
21 and lascivious act upon and with the body and certain parts and members thereof of B.N.,  
22 a child under the age of fourteen years, with the intent of arousing, appealing to, and  
23 gratifying the lust, passions, and sexual desires of the said defendant and the said child, to  
24 wit the second time by the truck.

23 person 18 years of age and older, did engage in oral copulation and sexual penetration, as  
24 defined in Penal Code Section 289, with B.N., a child who was 10 years of age and  
25 younger, to wit second time in the R.V.
