21 above named defendant of the following criminal offenses:

22 Count 1

23 On or between January 20, 2011 and January 19, 2016, in the County of San Luis Obispo,
24 State of California, the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony,
25 was committed in that WILLIAM MARTINEZ PEREZ did willfully, unlawfully, and lewdly
26 commit a lewd and lascivious act upon and with the body and certain parts and members
27 thereof of Ravin Doe DOB 1-20-2002, a child under the age of fourteen years, with the

1 intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the
2 said defendant and the said child.

3 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
4 section 290. Willful failure to register is a crime.

5 NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse

23 California, the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony, was
24 committed in that WILLIAM MARTINEZ PEREZ did willfully, unlawfully, and lewdly commit
25 a lewd and lascivious act upon and with the body and certain parts and members thereof
26 of Mariah Doe DOB 5-20-1996, a child under the age of fourteen years, with the intent of
27 arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said
28 defendant and the said child.

1 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
2 1192.7(c).

3 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
4 section 290. Willful failure to register is a crime.

5 NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction
6 HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of
7 the jail or prison facility where you are incarcerated pursuant to Penal Code Section
8 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
9 resulting in a court order.

14 a lewd and lascivious act upon and with the body and certain parts and members thereof
15 of Mariah Doe DOB 5-20-1996, a child under the age of fourteen years, with the intent of
16 arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said
17 defendant and the said child.

18 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
19 1192.7(c).

20 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
21 section 290. Willful failure to register is a crime.

22 NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction
23 HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of
24 the jail or prison facility where you are incarcerated pursuant to Penal Code Section
25 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
26 resulting in a court order.
