above named defendant of the following criminal offenses:

17 On or about April 30, 2019, in the County of San Luis Obispo, State of California,
18 the crime of Resist, Obstruct, Delay Of Peace Officer Or EMT in violation of PC148(a)(1), a
19 Misdemeanor, was committed in that MICHAEL ANTHONY GUZMAN did willfully and
20 unlawfully resist, delay and obstruct Felix Ramirez who was then and there a peace officer
21 attempting to and discharging the duty of his/her office and employment.

22 The People hereby give notice of the People's intent to admit evidence of prior acts of
23 domestic violence pursuant to Evidence Code section 1109. These incidents include the
24 prior incident(s) described in the police report, chronological report, and/or tapes already
25 provided, and other alleged incidents of abuse, which will be provided as they are obtained
26 by the prosecution.

1 The People hereby notify defendant and defense counsel that the People intend to
2 proceed under the provisions of Evidence Code section 1370 should the victim become
3 unavailable at the time of trial.


