20 above named defendant of the following criminal offenses:

21 Count 1

22 On or about February 17, 2017, in the County of San Luis Obispo, State of California, the
23 crime of Perjury By Declaration in violation of PC118(a), a Felony, was committed in that
24 JOSIAH JAMES JOHNSTONE did unlawfully, under penalty of perjury, declare as true,
25 that which was known to be false, to wit: that Defendant had retained and paid for the legal
26 services of Ilan Funke-Bilu.

Count 2

On or about February 14, 2017, in the County of San Luis Obispo, State of California, the crime of Criminal Threats in violation of PC422(a), a Felony, was committed in that JOSIAH JAMES JOHNSTONE did willfully and unlawfully threaten to commit a crime which would result in death and great bodily injury to Confidential Victim, with the specific intent that the statement be taken as a threat. It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to Confidential Victim a gravity of purpose and an immediate prospect of execution. It is further alleged that the said Confidential Victim was reasonably in sustained fear of his/her safety and the safety of his/her immediate family.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).

Count 3

On or between February 9, and March 9, 2017, in the County of San Luis Obispo, State of California, the crime of Stalking in violation of PC646.9(a), a Felony, was committed in that JOSIAH JAMES JOHNSTONE did willfully, maliciously, and repeatedly follow, and did willfully and maliciously harass Confidential Victim, and made a credible threat with the intent that she be placed in reasonable fear for her safety and the safety of her immediate family.

Count 4

On or about August 31, 2017, in the County of San Luis Obispo, State of California, the crime of Stalking in violation of PC646.9(a), a Felony, was committed in that JOSIAH JAMES JOHNSTONE did willfully, maliciously, and repeatedly follow, and did willfully and maliciously harass Amanda Doe, and made a credible threat with the intent that she be placed in reasonable fear for her safety and the safety of her immediate family.
