23 California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony,
24 was committed in that JOY NOEL WILDE on and between February 1, 2016 and June 30,
25 2016, and while said defendant(s) was (were) an agent, servant, and employee of G.
26 Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and
27 personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars
28 (\$950) in any 12 consecutive month period.

Count 2

Between August 1, 2016 and December 31, 2016, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between August 1, 2016 and December 31, 2016, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 3

Between January 1, 2017 and June 30, 2017, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between January 1, 2017 and June 30, 2017, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 4

Between July 1, 2017 and November 30, 2017, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between July 1, 2017 and November 30, 2017, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 5

Between December 1, 2017 and December 31, 2017, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between December 1, 2017 and

1 December 31, 2017, and while said defendant(s) was (were) an agent, servant, and
2 employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann
3 Construction money and personal property which aggregates to a value exceeding Nine
4 Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

5 Count 6

6 Between January 1, 2018 and April 30, 2018, in the County of San Luis Obispo, State of
7 California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony,
8 was committed in that JOY NOEL WILDE on and between January 1, 2018 and April 30,
9 2018, and while said defendant(s) was (were) an agent, servant, and employee of G.
10 Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and
11 personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars
12 (\$950) in any 12 consecutive month period.

13 Count 7

14 Between May 1, 2018 and May 31, 2018, in the County of San Luis Obispo, State of
15 California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony,
16 was committed in that JOY NOEL WILDE on and between May 1, 2018 and May 31, 2018,
17 and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann
18 Construction, did unlawfully take from said G. Wiemann Construction money and personal
19 property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any
20 12 consecutive month period.

21 Count 8

22 Between June 1, 2018 and July 31, 2018, in the County of San Luis Obispo, State of
23 California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony,
24 was committed in that JOY NOEL WILDE on and between June 1, 2018 and July 31,
25 2018, and while said defendant(s) was (were) an agent, servant, and employee of G.
26 Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and
27 personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars
28 (\$950) in any 12 consecutive month period.

Count 9

Between August 1, 2018 and August 31, 2018, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between August 1, 2018 and August 31, 2018, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 10

Between September 1, 2018 and September 30, 2018, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between September 1, 2018 and September 30, 2018, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 11

Between October 1, 2018 and October 31, 2018, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between October 1, 2018 and October 31, 2018, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 12

Between November 1, 2018 and December 31, 2018, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between November 1, 2018 and

1 December 31, 2018, and while said defendant(s) was (were) an agent, servant, and
2 employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann
3 Construction money and personal property which aggregates to a value exceeding Nine
4 Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

5 Count 13

6 Between January 1, 2019 and January 31, 2019, in the County of San Luis Obispo, State
7 of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a
8 Felony, was committed in that JOY NOEL WILDE on and between January 1, 2019 and
9 January 31, 2019, and while said defendant(s) was (were) an agent, servant, and
10 employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann
11 Construction money and personal property which aggregates to a value exceeding Nine
12 Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

13 Count 14

14 Between February 1, 2019 and February 28, 2019, in the County of San Luis Obispo,
15 State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a
16 Felony, was committed in that JOY NOEL WILDE on and between February 1, 2019 and
17 February 28, 2019, and while said defendant(s) was (were) an agent, servant, and
18 employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann
19 Construction money and personal property which aggregates to a value exceeding Nine
20 Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

21 Count 15

22 Between March 1, 2019 and March 31, 2019, in the County of San Luis Obispo, State of
23 California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony,
24 was committed in that JOY NOEL WILDE on and between March 1, 2019 and March 31,
25 2019, and while said defendant(s) was (were) an agent, servant, and employee of G.
26 Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and
27 personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars
28 (\$950) in any 12 consecutive month period.

Count 16

Between April 1, 2019 and April 30, 2019, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between April 1, 2019 and April 30, 2019, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 17

Between May 1, 2019 and May 31, 2019, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between May 1, 2019 and May 31, 2019, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 18

Between June 1, 2019 and June 30, 2019, in the County of San Luis Obispo, State of California, the crime of Grand Theft By Embezzlement in violation of PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between June 1, 2019 and June 30, 2019, and while said defendant(s) was (were) an agent, servant, and employee of G. Wiemann Construction, did unlawfully take from said G. Wiemann Construction money and personal property which aggregates to a value exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

Count 19

Between May 1, 2019 and July 31, 2019, in the County of San Luis Obispo, State of California, the crime of attempted Grand Theft By Embezzlement in violation of PC664/PC487(a), a Felony, was committed in that JOY NOEL WILDE on and between

1 May 1, 2019 and July 31, 2019, and while said defendant(s) was (were) an agent, servant,
2 and employee of G. Wiemann Construction, did unlawfully attempt to take from said G.
3 Wiemann Construction money and personal property which aggregates to a value
4 exceeding Nine Hundred Fifty Dollars (\$950) in any 12 consecutive month period.

5 Count 20

6 Between January 1, 2018 and March 31, 2018, in the County of San Luis Obispo, State of
7 California, the crime of Forgery in violation of PC470(A), a Felony, was committed in that
8 JOY NOEL WILDE did, with the intent to defraud, and knowingly without authority to do so,
9 sign the name of another person and of a fictitious person, to wit: G. Wiemann.

10 It is further alleged that the value of the check, bond, bank bill, note, cashier's check,
11 traveler's check and money order exceeded Nine Hundred Fifty Dollars (\$950).

12 Count 21

13 Between November 1, 2018 and November 30, 2018, in the County of San Luis Obispo,
14 State of California, the crime of Forgery in violation of PC470(A), a Felony, was committed
15 in that JOY NOEL WILDE did, with the intent to defraud, and knowingly without authority to
16 do so, sign the name of another person and of a fictitious person, to wit G. Wiemann.

17 It is further alleged that the value of the check, bond, bank bill, note, cashier's check,
18 traveler's check and money order exceeded Nine Hundred Fifty Dollars (\$950).

19 Enhancement

20 PC186.11(a)(2): Spec Alleg - Aggravated White Collar Crime

21 It is further alleged, pursuant to Penal Code section 186.11(a), that the offenses set forth in
22 Counts 1-21 are related felonies, a material element of which is fraud and embezzlement,
23 which involve a pattern of related felony conduct, and the pattern of related felony conduct
24 involves the taking of more than Five Hundred Thousand Dollars (\$500,000).

25 Enhancement

26 PC12022.6(a)(1): Spec Alleg-Excessive Loss Over \$65,000

27 It is further alleged as to Counts 1-5 that in the commission of the above offense(s) the
28 said defendant, JOY NOEL WILDE, with the intent to do so, took, damaged, and destroyed

1 property of a value exceeding \$65,000, within the meaning of Penal Code section
2 12022.6(a)(1).

3 Enhancement

4 PC803(c): Spec Alleg-Statute Of Limitations-Late Discovery (Zamora Allegation)

5 It is further alleged as to Counts 1 and 2, offenses described in Penal Code section 803(c),
6 that the above violation was not discovered until approximately July 2019 when the owner
7 of victim company discovered forged and otherwise falsified records, and that no victim of
8 said violation and no law enforcement agency chargeable with the investigation and
9 prosecution of said violation had actual and constructive knowledge of said violation prior
10 to said date because defendant, a trusted bookkeeper and office manager concealed the
11 fact she was stealing from said victim, within the meaning of Penal Code section 803(c).
