19 The District Attorney of the San Luis Obispo County, California, hereby accuses the
20 above named defendant of the following criminal offenses:

21

Count 1

22 On or about December 1, 2019, in the County of San Luis Obispo, State of California, the
23 crime of Murder in violation of Penal Code section 187(a), a Felony, was committed in that
24 CHELSEA ANNMARIE STILES did unlawfully, and with malice aforethought murder T.
25 Tilton, a human being.

26 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
27 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)

Enhancement

Penal Code section 12022(b)(1): Special Allegation - Use Of Deadly Weapon

It is further alleged as to count 1 that in the commission and attempted commission of the above offense, the said defendant , CHELSEA ANNMARIE STILES, personally used a deadly and dangerous weapon(s), to wit, a motor vehicle , said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

Count 2

On or about December 1, 2019, in the County of San Luis Obispo, State of California, the crime of Gross Vehicular Manslaughter While Intoxicated in violation of Penal Code section 191.5(a), a Felony, was committed in that CHELSEA ANNMARIE STILES did unlawfully, and without malice, kill T. Tilton, a human being, while driving a vehicle in violation of Vehicle Code sections 23140, 23152 and 23153 and said killing was the proximate result of the commission of an unlawful act, not amounting to a felony, and with gross negligence; and the proximate result of the commission of a lawful act which might have produced death, in an unlawful manner, and with gross negligence.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Sections 1192.7(c) and 1192.8(a).

Count 3

On or about December 1, 2019, in the County of San Luis Obispo, State of California, the crime of Driving Under The Influence Of Any Drug Causing Injury in violation of VC23153(f), a Felony, was committed in that CHELSEA ANNMARIE STILES did unlawfully, while under the influence of a drug, drive a vehicle and in so driving, concurrently did an act forbidden by law and neglected a duty imposed by law which proximately caused bodily injury to T. Tilton.

Enhancement

PC12022.7(a): Spec Alleg-Great Bodily Injury

It is further alleged as to count 3 that in the commission of the above offense the said defendant, CHELSEA ANNMARIE STILES, personally inflicted great bodily injury upon T. Tilton, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8).

NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)

Count 4

On or about December 1, 2019, in the County of San Luis Obispo, State of California, the crime of Assault With A Deadly Weapon - Motor Vehicle in violation of Penal Code section 245(A)(1), a Felony, was committed in that CHELSEA ANNMARIE STILES did willfully and unlawfully commit an assault upon G. Dicarlo with a deadly weapon, to wit, a motor vehicle.

It is further alleged that the foregoing offense was committed within the meaning of section 13210 of the Vehicle Code.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).

NOTICE: Conviction of this offense as a felony will result in the immediate and permanent revocation by the Department of Motor Vehicles of your privilege to drive a motor vehicle pursuant to Vehicle Code section 13351.5(A).

Count 5

On or about December 1, 2019, in the County of San Luis Obispo, State of California, the crime of Assault With A Deadly Weapon - Motor Vehicle in violation of Penal Code section 245(A)(1), a Felony, was committed in that CHELSEA ANNMARIE STILES did willfully and unlawfully commit an assault upon J. Dicarlo with a deadly weapon, to wit, a motor vehicle.

1 It is further alleged that the foregoing offense was committed within the meaning of section
2 13210 of the Vehicle Code.

3 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
4 1192.7(c).

5 NOTICE: Conviction of this offense as a felony will result in the immediate and permanent
6 revocation by the Department of Motor Vehicles of your privilege to drive a motor vehicle
7 pursuant to Vehicle Code section 13351.5(A).

8 Count 6

9 On or about December 1, 2019, in the County of San Luis Obispo, State of California, the
10 crime of Assault With A Deadly Weapon - Motor Vehicle in violation of PC245(A)(1), a
11 Felony, was committed in that CHELSEA ANNMARIE STILES did willfully and unlawfully
12 commit an assault upon C.D. with a deadly weapon, to wit, a motor vehicle.

13 It is further alleged that the foregoing offense was committed within the meaning of section
14 13210 of the Vehicle Code.

15 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
16 1192.7(c).

17 NOTICE: Conviction of this offense as a felony will result in the immediate and permanent
18 revocation by the Department of Motor Vehicles of your privilege to drive a motor vehicle
19 pursuant to Vehicle Code section 13351.5(A).

20 Count 7

21 On or about December 1, 2019, in the County of San Luis Obispo, State of California, the
22 crime of Assault With A Deadly Weapon - Motor Vehicle in violation of PC245(A)(1), a
23 Felony, was committed in that CHELSEA ANNMARIE STILES did willfully and unlawfully
24 commit an assault upon M.D. with a deadly weapon, to wit, a motor vehicle.

25 It is further alleged that the foregoing offense was committed within the meaning of section
26 13210 of the Vehicle Code.

27 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
28 1192.7(c).

1 NOTICE: Conviction of this offense as a felony will result in the immediate and permanent
2 revocation by the Department of Motor Vehicles of your privilege to drive a motor vehicle
3 pursuant to Vehicle Code section 13351.5(A).

4 Count 8

5 On or about December 1, 2019, in the County of San Luis Obispo, State of California, the
6 crime of Leaving The Scene Of Vehicle Collision in violation of Vehicle Code 20001(a), a
7 Felony, was committed in that CHELSEA ANNMARIE STILES did unlawfully, and
8 knowingly, being a driver of a vehicle involved in a vehicle collision resulting in injury to a
9 person other than himself/herself, fail, refuse, and neglect to give to the injured person and
10 to a traffic and police officer at the scene of the accident his/her name and address, the
11 registration number of his/her vehicle, and the name of the owner of said vehicle; to exhibit
12 his/her operator's license; to render reasonable assistance to the injured person; and
13 perform the duties specified in Vehicle Code Sections 20003 and 20004.

14 Count 9

15 On or about December 1, 2019, in the County of San Luis Obispo, State of California, the
16 crime of Child Abuse in violation of Penal Code section 273a(a), a Felony, was committed
17 in that CHELSEA ANNMARIE STILES did willfully and unlawfully, under circumstances
18 likely to produce great bodily harm and death, injure, cause, and permit a child, H.G.S (18
19 months of age), to suffer and to be inflicted with unjustifiable physical pain and mental
20 suffering, and, having the care and custody of said child, injure, cause, and permit the
21 person and health of said child to be injured and did willfully cause and permit said child to
22 be placed in such situation that his/her person and health was/were endangered.

23 Enhancement

24 Penal Code section 12022(b)(1): Special Allegation - Use Of Deadly Weapon

25 It is further alleged as to count 9 that in the commission and attempted commission of the
26 above offense, the said defendant , CHELSEA ANNMARIE STILES, personally used a
27 deadly and dangerous weapon(s), to wit, a motor vehicle , said use not being an element
28 of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing

1 the above offense to be a serious felony within the meaning of Penal Code section
2 1192.7(c)(23).

3 Count 10

4 On or about December 1, 2019, in the County of San Luis Obispo, State of California, the
5 crime of Possession Of A Controlled Substance in violation of Health and Safety Code
6 section 11350(a), a Misdemeanor, was committed in that CHELSEA ANNMARIE STILES
7 did unlawfully possess a controlled substance, to wit, cocaine.

8 NOTICE: Conviction of this offense will require you to register pursuant to Health and
9 Safety Code section 11590. Failure to do so is a crime pursuant to Health and Safety Code
10 section 11594.
