

HUD Grants

Community Development Block Grant (CDBG)

 Creates affordable housing solutions, suitable living environments, and economic opportunities.

Emergency Solutions Grant (ESG)

 Helps people experiencing or at-risk of homelessness through essential support services, street outreach, rapid re-housing programs, and homelessness prevention programs.

Home Investment Partnerships Program (HOME)

 Develops and rehabilitates affordable rental and home ownership opportunities by supporting below-market housing solutions and supporting rental assistance programs.

- PLHA provides funding to local governments in California for housing-related projects and programs that assist in addressing the unmet housing needs of their local communities.
