- 6. The Parties to this Stipulation consent to the immediate entry of the Judgment in the form attached and labeled as Exhibit 1, "Final Civil Judgment and Order According to Stipulation" ("Final Judgment"), before the taking of any proof and without trial or adjudication of any fact or law.
- 7. Defendants acknowledge that the Superior Court of the State of California, County of San Luis Obispo, has jurisdiction of the subject matter hereto, and has personal jurisdiction over Defendant.
- Payments are to be made according to the provisions set forth in the Final Judgment.
- 9. Defendants and their attorneys acknowledge the Final Judgment is a fair and reasonable resolution of matters alleged in the People's Complaint.
- 10. The Parties waive any right to set aside the Final Judgment through any collateral attack, and further waive their right to appeal from the Final Judgment.
